






## Countries with official Risk Assessments approved by FSC

This file lists all countries with official Risk Assessments approved by FSC International. The approved risk assessments are mandatory to be used by FSC Chain of Custody operations who are sourcing controlled material and controlling its origin according to FSC-STD-40-005. For your convenience, the file provides also a quick overview of the approved risk classification – “low risk” shown in green and “unspecified risk” shown in red. Official risk designations for each of the five categories of controversial wood are shown for each country. In the Global Forest Risk Register database (<http://www.globalforestregistry.org/>) you can navigate to the countries and click on them for complete risk information. Also the original risk assessment files as published by FSC National Offices, can be downloaded there. FSC is also maintaining a document, listing the countries with approved risk assessment (FSC-PRO-60-002a), which can be download from FSC website (<http://www.fsc.org>).
